Call for Student Entries: *Made Here: Juried Student Exhibition*

CRITERIA

Northern Arizona University's Beasley Gallery is pleased to invite student artists working in any media to submit entries for the *Made Here* Juried Student Exhibition. Works should be from your art classwork in the School of Art regardless of your major. Accepted works will be displayed in the Beasley Gallery in the Performing and Fine Arts building located in Flagstaff, AZ.

All visual media are welcome. Digital media and video works are limited to 15 minutes duration. All works must be no larger than 48 inches able to fit through a standard door. Works on paper should be unframed but ready to hang via magnets. Canvas should be wired. Pedestals are available for 3D works. TVs/projectors are available for 4D works. No special installation work will be accepted for this exhibition. The juror has final authority for selection.

Alan Petersen has lived, worked been inspired by the Colorado Plateau for 40+ years. Curator of Fine Arts at the Museum of Northern Arizona, Peterson's paintings and drawings have their source in the light, space and landforms from the regional landscapes, exploring the formal relationships between color and pictorial space.

SUBMISSION PROCEDURES

Artists may submit up to five (5) artworks for jurying. Works previously displayed in a Beasley Gallery exhibition will not be considered. All entries must be submitted jpg images and completed entry form to Beasley.Gallery@nau.edu. The JPG Images must be oriented properly (i.e., top of the image is the top of the artwork) and should NOT include artist's name or other descriptive text on the image itself. Images must be at least 1000 pixels wide in either direction and 72 ppi.

Files names must be labeled with the artists last name, first initial, underscore and the number of the entry; Example: PicassoP_1.jpg

If the image is a detail include "detail" in the file name: Example: PicassoP_1detail.jpg

Video/Digital work must be 15 minutes or less in length. To submit video work, share a link to an online platform such as YouTube or Vimeo. Artists submitting video must also upload a still image from the video. Selection of the work will be done by the juror from the files/video links submitted.

Artists may submit up to two images for artwork if a detail or alternate view is needed (for 3D work). The juror reserves the right to eliminate any work which does not meet the standards of quality for the exhibition.

Submitting an entry form to this exhibition constitutes an agreement on the part of the artist with all conditions to this prospectus. ***The School of Art & Design*** reserves the right to refuse any entry, if, upon arrival, the work is found unacceptable or significantly different from the representation submitted. No work accepted for the exhibition may be withdrawn before the close of the exhibition.

INSURANCE & LIABILITY The gallery will exercise every possible care in the safekeeping of loans in its possession, but doesn't insure work. Artists whose work is accepted will be send an Art Loan Agreement form and Assumption of Risk Agreement that outlines the release of liability assigned to Northern Arizona University. These forms must be signed and returned to the Gallery by all participating artists before the exhibition starting date.
